I understand by signing below that:

- All tuition for the prior school year program must be paid in full for my child to attend Summer Camp.
- All application fees are non-refundable/non-transferable.
- **Tuition is due on or before the dates listed below:**
 - Weeks 1-2/Session 1 May 18
 - Weeks 3-5/Session 2 June 8
 - Weeks 6-8/Session 3 July 8
- If tuition payment is not received by the tuition date, my child's Summer Camp space may be forfeited.
- Tuition payments must be made on-line or at University Center - Child Care Office.
- Changes and or cancellations made after tuition due dates, but prior to deadline dates listed below, will receive a 50% refund or a 50% transfer of tuition. Requests made after the deadline dates listed below will forfeit 100% non-transferrable tuition payment for that session.
- **DEADLINE Dates for Changes in Enrollment:**
 - Weeks 1-2/Session 1 May 21
 - Weeks 3-5/Session 2 June 12
 - Weeks 6-8/Session 3 July 15
- There shall be no credits, refunds or "make-up" days for missed days of camp. Tuition is not pro-rated for days missed or holidays.
- No child care shall be provided on-site for those that do not participate in the field trips and tuition rates remain the same.
- A Late Pick-Up fee of \$1.00 per minute, per child, shall be charged for pickups after 6:00 p.m.
- Changes must be called into the Child Care Office at 805-492-3567
